# Functions and performance levels:

to reduce the severity of traumas caused by impacts. The protectors provide limited protection against mechanical impact in case of falls.

Method: "kerbstone" at 50J.

<u>Mandatory tests</u>: impact test <u>performed</u> at standard ambient conditions and after <u>hydrolytic</u> treatment (wet conditions) = level 2.

OPTIONAL requirement: at low temperature (24 h / -10°C) = level 2.

The overall protective level is therefore: level 2.

NOTE: the reference Standard EN 1621-2 provides 2 performance levels and level 2 is the one offering higher performances.


